General Assembly

General Assembly Committee 1 (Disarmament and International Security)

- ◆ Establishing a legal framework for the utilisation of cyber-attacks in modern warfare
- ◆ Discussing the issue of privatised arms companies to prevent an unregulated weapons distribution
- ◆ Advancing global efforts to decommission nuclear facilities

General Assembly Committee 2 (Economic and Financial)

- ◆ Assessing the effects of cryptocurrency in economic growth and energy use in developing countries
- ◆ Discussing the reduction of the wealth gap through progressive taxation and social policies
- ◆ Encouraging closing the digital gap in developing countries to promote equitable access to technology

General Assembly Committee 3 (Social, Cultural & Humanitarian)

- ◆ Discussing the restrictions on religious attire in public places
- ◆ Addressing the humanitarian situation in mega-prisons and detention camps
- ◆ Ensuring the safety of journalists and strengthening press freedom in the face of global threats and censorship

General Assembly Committee 4 (Special Political and Decolonization)

- ◆ Combating the disregard for attributed territorial land and borders
- ◆ Addressing the rights of indigenous and tribal communities worldwide
- ◆ Addressing the issue of potential political influence of corporate monopolies

General Assembly Committee 6 (Legal)

- ◆ Establishing methods to combat narcotic production and trade
- ◆ Reviewing legal and social frameworks on prostitution
- ◆ Debating the reduction of animal testing in the cosmetics and medicine industry

Economic and Social Council

ECOSOC Committee 1 (Environment, Social and Governance)

- ◆ Addressing the impact of climate change on the increasing frequency and severity of natural disasters
- ◆ Discussing immigration due to extreme climate change
- ◆ Contemplating potential government regulations on online platforms regarding extreme political content

ECOSOC Committee 2 (Crime Prevention and Criminal Justice)

- ◆ Discussing the implementation of automatic facial recognition in public spaces to prevent crime
- ◆ Analysing the impact of excessive migration and of rising hostilities towards migrants
- ◆ Discussing the legalisation of assisted suicide for terminally ill patients

ECOSOC Committee 3 (Human Rights)

- ◆ Addressing the issue of forced labour in prisons
- ◆ Discussing methods for the protection of children from online exploitation
- ◆ Discussing accessible healthcare for vulnerable populations worldwide

Security Council

- ◆ Combating online radicalisation and cyberterrorism, with a focus on anonymous networks
- ◆ Discussing the role of artificial islands in the south Chinese sea conflict
- ◆ Addressing the growing military presence in the Arctic and the potential risks of escalating tensions among occupying countries
